SUN LAKES COMMUNITY THEATRE GENERAL MEMBERSHIP MEETING FBRUARY 9TH 2012 COTTONWOOD COUNTRY CLUB

CALL TO ORDER: 7PM and recognition of a thank you note from a Mrs. Patterson, Assistant Principal of Special Events at Perry High School sent through Carole and Bob Hollar thanking SLCT for the \$1000 gift to their drama department. In return "comp" tickets to their performance of "Grease" will be offered for their March 1st – 3rd performance.

MINUTES OF LAST MONTH: Secretary Michael of SLCT read the minutes of January's General membership meeting. A motion to accept the minutes was made by Jim Nielson and seconded by Kathy Markham. Motion carried.

TREASURER'S REPORT: Treasurer Jeanne reported that SLCT has \$6935.03 in our checking account and \$25,515.27 in our saving's account. Jeanne also reported that \$1000 donation to each of the four area high schools will be presented to the high school drama coaches who are expected to be present at the March membership meeting.

INTODUCTION OF NEW MEMBERS AND GUESTS: Merrie reported that we have a new member Beverly from Minnesota as a former musical director and Joyce and Rodni as guests.

UPCOMING PLAYS: Howard introduced the spring play "Play On" that will run April 10th-14th. Howard indicated that meals would be served at each of the performances to those patrons who so choose to have a meal. There will be a raffle for tickets to either the spring or summer play. "Clues" will be at each table with the raffle going to the patron with the correct answer. Answer sheets can be deposited at designated areas at Cottonwood. Drawing will be after the last performance.

Linda is directing Woody Allen's "Don't Drink The Water" that will be running July 18th – 22nd. Auditions were held February 4th. Linda also introduced the cast she selected. Carole Hollar will be Linda's assistant. Sandy introduced the fall mystery dinner theatre "Murder at the Café Noir" that she is directing to be held at Oakwood during Halloween week; October 28th, 29th 30th, 31st, November 1st, and 2nd. Auditions for the play will be announced in the "Asides".

NOMINATING COMMITTEE REPORT: Bud Jenssen reported that there are four candidates for two opening on the SLCT Board with Merrie Crawford and Phyllis Novy leaving. The candidates presented are Grace Geisinger, Jim Nielson, Bob Rouleau, and Howard Hummel. Grace, Jim, and Howard presented their bio with Bob withdrawing his name from the nomination. Nominations were solicited from the floor with no takers.

Bud also introduced the voting process and will be assisted by MaryAnn Stevens. Each paid member will receive a ballot at the March membership meeting. There will also be a provision to vote by mail provided the member has their name on the envelope. Andrea Hummel spoke about the ordering of t-shirts/polo shirts.

Phyllis Novy introduces the evening's entertainment performed by our own SLCT "Improvables".



SUN LAKES COMMUNITY THEATRE BOARD OF DIRECTORS BOARD ACTIONS OF THE 2011/2012-YEAR HIGHLIGHTS

- April 2011 meeting new officers were selected. Merrie Crawford as President; Bud Jenssen as Vice President; Michael Carter as Secretary; Sandy Pallett and Phyllis Novy as Program/Education Coordinator; Sue Youngblood as Communications Coordinator; and Linda Caton as Production Liaison.
- Bylaw changes became available on SLCT website.
- Approval of "Children's Theatre" under the directorship of Roger Edmonds.
- A schedule of 2011/2012 shows was provided (Murder in McCobb's Directed by Harlie Youngblood; Fools Directed by Linda Caton; 100 Lunches Directed by John Crawford; Play On Directed by Howard Hummel SLCT new director.
- <u>June 2011</u> meeting future assets such as lights, sound, makeup, and fixtures will come from the general fund not the director's budget. Directors may request cash advances for expenses.
- Improv workshop was approved with 12 people signed up for the June 18th begin date that would morph into an ongoing improv group called the "Improvables" coordinated by Phyllis Novy and Sandy Pallett.
- A cocktail party was held at Oakwood that was a huge success.
- <u>September 2011</u> meeting Phyllis Novy proposed a "happy half hour cocktail" prior to each general meeting.
- Sandy Pallett introduced "Chef Series" held at Oakwood.
- New theatre lighting equipment was discussed.
- Merrie led a discussion of who will maintain email lists and should there be a "patron" email list separate from a member/donor list with the purpose to inform the general public of upcoming plays.
- Board approved new software that would generate show tickets and eliminate hand numbering of each ticket introduced by John Crawford.

- October 2011 meeting Jeanne Schwan presented a handout "Notes for Directors" highlighting the various costs associated with a director's \$5000 budget.
- Linda Caton_was approved to direct the summer play by Woody Allen "Don't Drink The Water"
- Sandy Pallett was approved to direct a "Mystery Dinner Theatre"
- The purchase new lighting equipment and a DMX board from Clearwing were approved.
- November 2011 meeting John Dobson donated over \$8,600 to SLCT for the new and improved lighting for the San Tan stage.
- Linda Shanahan and Jo Birlin contributed a "mixer" to SLCT.
- "Angels" clarification: All names of donors living as well as deceased that appear on the plaque will also appear on each play's program.
- <u>January 2012</u> meeting brought to light the need for new wiring at San Tan that was left out of the quote from Clearwing.
- Perry High School (new school to Chandler area) was added to the existing three high schools (Hamilton, Chandler, and Basha) to receive a \$1000 donation from SLCT
- Donations must agree with SLCT mission statement.
- "Asides" will highlight SLCT accomplishments that would promote positive publicity and public relations.
- Bud Jenssen reported the need for a nominating committee for the upcoming SLCT elections.
- SLCT will not lend out any of our equipment due to time and expense of doing so.
- <u>February 2012</u> meeting reported that representatives from the four area high schools would be present at the March annual meeting to accept the \$1000 donations.
- Future "Asides" publications would have a monthly message from the SLCT president and profile of a current board member.
- The Theatre season is spring, summer, and fall. SLCT presented "Fools" directed by Linda Caton, "100 Lunches" directed by John Crawford, and "Play On' (spring 2012) directed by Howard Hummel.
- The fall play "Murder at the Café Noir" is to be directed by Sandy Pallett at Oakwood as a mystery dinner theatre.
- Jon McCoy is to be recognized for his time and talents that he contributed to SLCT. John is moving out of Sun Lakes.

He was the Producer of Penny Petersen's play, "Reunited" (later re-named "Reunion") and was in charge of all backstage personnel, finances, props, etc. etc.

Jon served on the SLCT Board and was the club treasurer for 10 years. That's a lot of bucks to keep track of for that long. In addition, he contributed his time as a techie doing props, painting sets and crawling under the risers to fasten them together until hip problems prevented it. He and Beverley also ushered.

In addition to his many involvements in SLCT activities, Jon was in Rotary and served as President of that organization in 2004. He and Beverley were members of the Sun Lakes Chorale for four years, Jon a tenor and Beverley a soprano. They participated in bowling, and he was a member of Rock and Gem Club for a few years. Golf provided much pleasure for the couple and until a few years ago, Jon played three times a week. Now he's restricted to playing with Tanner, his three year old rescue dog.

Every week for many years, Jon and Beverley participated in and helped with the Monday night Horse Races at Cottonwood. And, if you've ever seen SANTA CLAUS at Palo Verde Clubhouse or somewhere else during the holidays, it was Jon, complete with real beard and jolly "ho, ho, hos."

Like many Sun Lakes residents, Jon and Beverley came from Minnesota (the Minneapolis area). They were junior high sweethearts who married in 1954 and eventually migrated to Detroit (6 yrs), Ames, Iowa (17yrs), New Jersey (3 yrs) and Chandler, Arizona prior to moving to Sun Lakes in 1996.

When asked about living in Sun Lakes on a lake, Jon said, "We've loved Sun Lakes. The crowds of people, some walking dogs, bikers, even the ones in golf carts, they're all fantastic, friendly and we'll miss them."
