
## SLCT is a Well-Wired Organization




Auditions are open to anyone who is a resident of Sun Lakes or Sunbird, but anyone receiving a part will be expected to join the Sun Lakes Community Theatre (SLCT).

In addition, those interested in auditioning should also watch the DVD starring Henry Fonda and Lee J. Cobb to understand the staging of the original production and to see the roles each of the jurors play. The Maricopa County Library system has copies of the play, which can be requested through the Robson Library.

This Emmy award-winning play by Reginald Rose was originally written for television and has proven to be a timeless piece in its exploration of human nature.

Rehearsals for the play will begin in mid-September.

## Sun Lakes Country Club Presents



The SLCT Play Reading Committee has spent many hours of discussion and meetings developing guidelines that insure SLCT's compliance with federal copyright laws. We commend them and their efforts. The updated guidelines have been approved by the Board of Directors.

#### GUIDELINES FOR EVALUATING AND REVIEWING SCRIPTS

- 1. A play submitted by a director for approval by the Play Reading Committee (PRC) must adhere to all copyright laws. Deviations from copyrighted scripts, including substantive changes, play snippets and videotaping, must have written approval of the author and/or the publisher, and that written permission must be submitted to the PRC prior to the beginning of rehearsals. Failure to adhere to the above will constitute a copyright infringement and may subject SLCT to significant financial liabilities
- 2. A play selected by a director that has not been performed by SLCT will require PRC approval.
- 3. Plays listed on the SLCT website ("Past Productions") as having been performed in the past will not require a PRC approval.
- 4. Play subject matter should be appropriate for Sun Lakes audiences with an approximate production run time not to exceed two hours (not including intermission).
- 5. A director who submits a play to the PRC for a final approval and is rejected has the right to petition the BOD.
- 6. The PRC will forward the list of approved plays and the directors who have submitted them to the BOD.

NOTE: It is neither the intention nor desire of the Play Reading Committee to impose restrictions that interfere with a director's creativity, but rather to protect SLCT from copyright infringement and financial liability. We rely upon the integrity and discretion of a director to stay within the copyright parameters set forth by the publisher and to seek written permission from the author/publisher when necessary. Also, the current play list on the SLCT website will remain as a resource list and be considered as a library and NOT as an approved play list. THE ONLY APPROVED PLAYS ARE THOSE THAT APPEAR AS "PAST PRODUCTIONS".

- "MEMBERSHIP": The membership of the PRC committee consists of seven (7) members of SLCT and a non-voting board liaison member.
- "PLAY READING PROCESS ITEM #7": If approved by five (5)votes, the chair will send approval to the BOD.
- "ITEM # 8": If not approved by five (5)votes the chair will return the play to the director for changes and reasons for the rejection.
