Recent updates and decisions:

Report from our Treasurer, Cindi Decker, that she applied for a new ACA-ORG state grant, and she received an email that SLCT has been awarded one in the amount of \$6,000 to be paid sometime in December. This ORG grant will balance our budget for this fiscal year. Big thanks to Cindi for all the work she does for SLCT.

Opinion by Bill Becker: SLCT and the COVID vaccine

The following has not been acted upon by the Board of Directors, but it is my opinion about what will probably happen this spring and summer of 2021.

Information from the AZ Department of Health concerning the COVID vaccines schedule. With the first doses of the coronavirus vaccine expected to be available in Arizona this month, state health officials on Friday laid out a plan for distribution and the priority list for those wanting to receive the treatment. The plan is a more solidified — but not final — version of a draft the Arizona Department of Health Services posted in October in preparation for vaccine distribution. Dr. Cara Christ, ADHS director, revealed that the state is projected to receive more than 380,000 doses by the end of December. The initial doses will be reserved for individuals in the top priority group (1A), which is estimated to include about 400,000 eligible Arizonans, which includes health care workers, long-term care high-risk residents and staff at those residential facilities.

The vaccine is expected to be available for those in that group within 48 hours after they are received, according to Christ. "It's a lot of people with limited vaccine coming in," Christ said during a press briefing. "We are going to provide those high-risk groups with that opportunity by the start of the year." More than 1,000 provider locations in the state have started the onboarding process for vaccine distribution and about 350 locations have been approved for it. Most sites will directly receive vaccine shipments, according to Christ. She also wants as many mass vaccinations sites as possible. She hopes they are similar to the large, drive-in sites that are currently being used to test for COVID-19.

Quicker distribution would likely result in those in the **secondary priority group (1B)** — **notably educators** — getting access to the vaccine in a more-timely manner. Those in secondary priority group also include **essential workers such as law enforcement and fire personnel and food service employees.** "We anticipate getting the vaccine to some of our highly prioritized groups probably around the beginning of January," Christ said. The Moderna and Pfizer vaccines are the two that will be initially available to Arizonans. Both vaccines require two doses that will need to be administered either 21 or 28 days apart to ensure full vaccination.

Group Level 1C: TBD by jurisdiction. People at increased risk for severe COVID-19 disease.

- 1C Adults with underlying medical conditions (obesity, COPD, heart disease, diabetes, chronic kidney disease)
- 1C Adults 65+ years and older.
- 1C Adults living in congregate settings TBD by jurisdiction.

Christ expects "hundreds of millions" of vaccinations to be available to the third priority group "by March or April when they will be administered to the general population".

As to SLCT and our Sun Lakes communities, it appears that the majority of our local senior citizens will not be fully vaccinated until late April or May 2021 (shots 21-28 days apart). So, it is evident that we cannot produce our tentatively-scheduled spring play, "Catch Me If You Can", with a cast and crew and a live audience inside in the San Tan Ballroom from April 25-May 2.

However, it may still be possible to do the summer play, "The Red Velvet Cake War", as it is scheduled for July 13-17 in the San Tan Ballroom; we will have to wait and see about that one, and the Board of Directors would have to make the decision in late April to give the director, the cast, the technical crew, publicity and ticket sales enough time to prepare for the show.

A fall play or show has not yet been selected by the Board.


Adopt a Family at Christmas project
