Treasurer's Report: Motion made, seconded and carried to Approve the April 30, 2016 Financial Report.

Budget Report: Barry Berger questioned the Lighting Budget. Kathy Jones will clarify who will pay for repairs or new equipment, HOA or SLCT. The Board will take approximately \$14,000 from the SLCT Reserve in Checking Account to pay for additional Sound Equipment. The Budget Report was approved as written and passed unanimously.

Grants: Howard Hummel will help with Grants. He had questions regarding 1) the purpose and 2) what types of Grants are needed. Grants should include: 1) lighting equipment; 2) sound audio equipment; and 3) education for schools and retirement communities within the Chandler Community. Board voted of the need for Grants. All were in favor, motion carried.

Donations/Sponsors: Need a Committee to look into getting Sponsors from the Community. Roxanne Banta agreed to be responsible. This item was tabled for a future Board Meeting.
