SUN LAKES COMMUNITY THEATRE GUIDELINES FOR COVID-19 RESPONSE

Our first concern is for the health and safety of our members and patrons. Covid vaccination will be required for individuals participating in SLCT productions, or attending other in-person events or activities until further notice (requests for exemptions, such as medical, will be addressed by the Board). Facial coverings or masks are not required but may be worn by personal preference.
