Accept minutes of last meeting

Treasurer's report - Cindi

MJ looked into catering at Cottonwood and found that we could save money in the future by informing them every day on what we need instead of leaving it up to them. She reported that we could have saved about \$450.

Community Day/Open House 10/9/21 at Cottonwood, date for Oakwood – Sandy

The date for the Oakwood community day is up in the air right now. The Sun Lakes Country Club will hold one on Oct. 23.

Fall show 2021 Sandy

Sandy had 18 auditioners, some of them new to SLCT. She cast 9 in the roles that are scripted and is creating roles for the other 9. She is looking for 1 or 2 people to work backstage for her production. She will be able to accommodate 120 audience members per night and tickets for the dinner and show will be \$45 each.

Spring show 03/27-4/2/22 Diana Nelinson's Catch Me If You Can Update

Diana is still planning on it. She plans to write a description of the show and have Jim Nielsen send it to the membership in an e-blast.

Summer show 07/11-17/22 Red Velvet Cake Wars – Status

Linda Caton is still planning on it. Sandy Bocynesky will be her backup.

Fall Show 11/6-12/2022 Proposal from Roger

Roger is proposing to direct an "Evening on Broadway" in the fall of 2022. Two narrators might talk about the history of Broadway interspersed with music from Broadway shows. He wants to include some children for a couple of songs. There was a lot of discussion on our ability to find enough singers, the difficulty of a show like this to produce and if it would affect our summer show or the upcoming Chordaires show.
