Call to Order: 10:05AM

Motion to approve MINUTES of July 8 meeting made by Bill and seconded by Mary. Slight change of wording: Replace "lights" with "tripods" and change wording to reflect 3 sets rather than 6 sets, with appropriate price reduction. Discussion. **Motion approved.**

Load-in will be 10/21 Tues. 9 a.m. (Will need SLCT volunteers plus hire outside help for this.) The risers will be set up: 10/22 Wed.: a.m. + Tech./dress rehearsal: Wed. 10/22: 4-7 p.m.

Motion to liquidate "truss system" was passed at the July meeting. **Update**: There is a potential buyer for the trusses, but he says he cannot buy them until September, so we are waiting for that.

Financial/Treasurer:

Re: Possible rental space in the ACE Plaza. Michael Robson promised Sandy that he would forward a contract.

QUESTIONS/CONCERNS ASKED AT MEETING:

Carol: A "standard" contract was sent by Robson's attorney to her and distributed to the Board members for review. Members were encouraged to create an SLCT version of the lease so our interests are voiced. Accordingly, the President appointed a subcommittee of the Board: Bill Becker, Howard Hummel and Mary Vandergriff, to do so and report back to the Board with a new document that spells out SLCT's version of such a lease, if we were to sign one. This will be ready for discussion at the September 10 board meeting.

Shows updates:

No new updates on regular production shows: same information as last meeting for both the fall and spring shows; nothing organized yet for the summer show except the dates are established: Red Velvet Cake War. Director is Linda Caton with Asst. Director Sandy Bocynesky, show is at Cottonwood. Sun. 7/12 matinee at 1 pm, dark Mon. & Tues., plus shows Wed 7/15 –Sat.7/18: evenings at 7 pm

QUESTIONS/CONCERNS ASKED AT MEETING:

NEW INFORMATION: Sandy indicated that she will be presenting a small show of two or three short plays at Poolside May 6-10, 2019. Approximately 40 people per performance. Price to be determined. These May dates will not interfere with "You're a Good Man, Charlie Brown" from April4 -9.

OTHER THAN APPROVAL OF THE PAST MINUTES AND FINANCIALS, THERE WERE NO OTHER MOTIONS MADE AT THIS MEETING.

<u>Tabled items</u>: Increasing prices of upcoming ticket for shows, a possible membership dues increase, revisiting the issue of donations to the Chandler High Schools, and updating the descriptions of roles of Board members.
