Grant report – Cindi

Summer show last week of July – Advertising signs

The outside signs posted advertising our shows don't need all the details that our flyers and hand-outs have. They should have our logo, the show title, performance dates and times, when ticket sales start, our website and phone number and the required legal information in the fine print.

Other issues, such as sign colors and branding were discussed without deciding on any changes to what we are doing.

New Cost of Doing Business – MJ

We don't always get enough members to help with the heavy work. The board agreed to pay \$20 per hour for outside help.

Rehearsals will start the end of August with performances just before the Fall show to advertise tickets sales.
